**Sub: Mop-up SPOT counseling for M (Madhyamik or equivalent) & E group (Class 8 pass) candidates.**

The Mop-up SPOT counseling in the vacant seats of M group & E group trades will be conducted as per following schedule on the basis of "FIRST COME FIRST SERVE".

**General guideline for the SPOT counselling:**


1. Merit listed non-admitted candidates of M Group, who could not participate in the online counselling are eligible to take admission through SPOT Counselling.
2. Merit listed non-admitted candidates of E Group, who could not participate in the online counselling are eligible to take admission through SPOT Counselling.
3. New candidates may register themselves for taking part in this SPOT-COUNSELLING only for M group. However they will be treated as NON-RANK Holder Candidates.
4. Seats against discharged candidates may also be considered to fill up.
5. M Group applicants are also eligible to choose any E Group trades of his/her choice. However, E group candidates can only choose E group trades.
6. Seats will be allotted in the **vacant seats irrespective of quota** of ITI on **First come first serve basis**. However, for the 11 new ITIs all the statutory reservation will exist.

7. Candidates must check the vacancies of Seat Matrix on the <https://scvtwb.in> and set their priority of choosing ITI / Trade during SPOT counselling.
8. Failure to report at the scheduled date and time will make the candidate ineligible for counselling.
9. **Allotment of a seat depends on availability of vacant seat at time of his/her turns.** SPOT counselling will continue till there will be availability of seats and the counselling will be stopped when all eligible vacant seats will be filled up.
10. Already admitted candidates will not be allowed to take part in this phase of counselling. However, the discharged candidates may take part in the counselling and he/she has to pay requisite fees like fresh candidates.
11. Seats will be allotted in the vacant seats of ITI on **“First come First serve” basis .**
12. Candidates must check the vacancies of Seat Matrix on the <https://scvtwb.in> and set their priority of choosing ITI / Trade during SPOT counselling.
13. Failure to report at the scheduled date and time will make the candidate ineligible for counselling.
14. **Once a seat is allotted to a candidate through SPOT counselling, the candidate has to pay and get admitted with in 7.30P.M of that day, failing of which his/her allotted seats will be cancelled.**
15. Head of the institute is advised to take necessary steps so that law and order of his/her institute is maintained.
